Dear Sirs,

Please be advised that we, Johnson & Johnson, were made aware of a suspect counterfeit case related to Darzalex 400mg/20mL IV reported from Iran.

Pictures received are listed under Appendix 1.

As per the pictures received, the lots are invalid and the appearance does not match with the official Darzalex IV artwork intended for the US market, therefore, a counterfeit conclusion is confirmed.

As per the information received, the patient purchased the medicine through unauthorized channels in Iran.

Since the suspected pack has been purchased outside the authorized distribution network of Johnson & Johnson in Iran, we cannot guarantee nor be held responsible for its safety, authenticity, performance, mechanical properties, biocompatibility, or sterility.

Purchasing pharmaceutical products from the official and authorized channels in Iran will ensure patients are receiving products strictly complying with the Ministry of Health Authority's standards and regulations, as well as with the stringent shipping and storage conditions intended for these products by the legal manufacturer.
